MISSIONER'S AGREEMENT AND RELEASE OF ALL CLAIMS

Mission On The Move suggests the following guidelines. Not every person is able to adapt to the expectations of missionaries, but no person should go on such an experience totally unprepared. M.O.M. team members are not tourists; they go at the invitation of another church as guests. It is extremely important to be willing to adjust to the expectations of the host church and Team Leader. Your decision to go should be done after consultation with your family and your pastor.

Therefore, in consideration of the permission granted to me by the M.O.M. organization to participate in the above-described project during the above dates of the mission, and in consideration of the other obligations incurred by the mission organization during this mission activity, I hereby agree as follows:

1. I agree to share my faith in an appropriate manner while on the mission.
2. I agree to cooperate at all times with the Team Leader concerning the work assignments, the food, lodging, and accommodations provided for the team and to stay with the team from beginning to end.
3. I agree to abstain from the use of alcohol and tobacco while on the total experience of this mission. (The use of alcohol and tobacco in Latin America is particularly taboo and would destroy the effective witness of a volunteer team.)
4. I hereby release and discharge the mission organization, Mission On The Move, its agents, employees, and officers, from all claims, demands, judgments, and executions which I ever had, or now have, or may have, or which my heirs, executors, administrators, or assigns may have, or claim to have, against the mission organization, its agents, employees and officers, and its successors or assigns, for all personal injuries, known or unknown, and injuries to property, real or personal, caused by or arising out of the above-described mission activities.
5. I hereby acknowledge that by engaging in the above-described mission activities, I am subjecting myself to certain risks, including and in addition to those which I normally face in my personal and business life, including but not limited to such things as health hazards due to poor food and water, diseases, pests, and poor sanitation; potential injury while working; and inadequate medical facilities, etc.
6. ***I agree not to give any cash or gifts to any particular National without the approval of the Team Leader and Resident Missionary.*** I also agree not to make contact with any Nationals after the departure of the Team for the purpose of giving cash or gifts without the approval of the Director of Mission On The Move and the Resident Missionary.
7. ***I agree not to give any invitation to any National to return with the Team to the United States or even to imply that arrangements will be made for a visit or permanent stay in the U.S.***
8. I agree to pay in full my portion of the mission no later than thirty (30) days prior to the date of departure.
9. I have read this release and understand all of its terms. I execute it voluntarily and with full knowledge of its significance.
